Start of a new chapter

When Rona Stalley first moved into RAAFA's Bull Creek community in 1987, residents weren't allowed to hang washing out at the weekend, and 'everything' had to be painted mission brown.

"When I shifted in, everyone had little plots of garden which they tended to regularly, and you needed permission from the office to pretty much do anything," says the 93-year-old, who moved into Air Force Memorial Estate (AFME) when she was in her mid-50s.

"But look, you have to have progress, and although I was sad to leave Harris House, I have very many happy memories and I think we are all really excited to see the new building," Rona adds.

Last month, AFME's Sivyer, Harris, Ingram and Fraser units - known as SHIF for short - were demolished, heralding a new and exciting chapter for the estate.

But the new era also prompted a trip down memory lane for many.

Another long-term resident, 93-year-old Delys Ferguson, who has lived in her unit at SHIF since 1991, remembers being greeted when she first moved in by a previous resident, who was a very strict ex-headmistress.

"Hilda told us that we couldn't do any washing on a Sunday, but I remember Harry, another resident who lived downstairs at the time, retorting 'don't worry, no one tells me what to do'," she laughs.

"It's funny what you remember, but at the end of the day we had a lot of fun in our unit, everyone was friendly and we were all there for each other even though we didn't live in our neighbours' pockets. "I'm not sentimental, so leaving my old home at Ingram wasn't hard, but it was made a lot easier by the help we received during the moving process, which couldn't be faulted. I'm so happy with my new two-bedroom unit, I have beautiful views and I'm very happy," adds Delys.

Penny John, AFME Estate Manager, says the demolition of SHIF has gone very smoothly.

"While the residents have been quite nostalgic at times, and several watched the demolition take place, they are also quite excited about the future Stirling building," she says.

"Everyone has been reassured that the mature trees along the creek at Fraser House will remain to create a beautiful outlook from the south facing Stirling apartments. And the garden along the northern boundary will also be maintained during the construction phase."

Indeed, the position of the new building is certainly a hot topic at the estate.

"The new building is in a wonderful position and the new high-rise is going to have beautiful views, in fact I'd say they'll be the most soughtafter in Perth," adds Rona.

"There won't be any other obstructions when it comes to the views, and people will be able to look straight back up the river. It's going to be a great place to see the city lights and also the fireworks on Australia Day."



Aviators honoured

One of the joys I have as State President is to represent the

Association at RAAF Base Pearce for the Australian Defence Force pilots' course graduation ceremony and to present our Award to 'the graduate who has shown the most improvement'.

Congratulations go to Pilot Officer Angus Johnston of No.266 PC-21ADF Pilots' Course held on 29 July 2022.

No.1 Advanced Flying Training School was relocated to Pearce from Point Cook in 1958. The Vampire was in use as a training aircraft at that time, but by 1969 they had been replaced by the more modern Macchi MB326H aircraft. The unit was then reformed as No.2 Flying Training School (2FTS).

20 years later the Swiss-designed, Australian built Pilatus PC9/A turbo-prop trainer for advanced undergraduate pilot training was introduced and served well until replaced by the Pilatus PC-21 in September 2018.

2FTS provides training in advanced general instrument, night and formation flying, and navigation. A graduate pilot in the ADF must be capable of flying with the skill and confidence necessary to allow ready transition to selected operational aircraft.

The most recent course graduation was No.266 and it was an honour once again to present our Award

and to recognise the outstanding calibre of the young men and women of the Air Force and Navy graduating as pilots from Pearce.

Aviators remembered

The Association was honoured to have the RAAF conduct a ceremony for the WA relatives of aviators lost 70 years ago when Catalina A24-50 failed to return from a sea-mining mission from Cairns to Sorong Harbour in what is now Papua, Indonesia.

The wreckage in which 10 aviators perished was found in 2018. Early reports suggested that the aircraft had probably struck one of the mountains, especially as bad weather had been reported. No wreckage was found at the time, despite extensive searches.

Recently a brief, warm and caring memorial service was conducted by the RAAF at AFME for the lost crew. It included a presentation on the events surrounding the tragedy. given by senior RAAF Officers, followed by a brief memorial service in the Museum where wreaths were laid under the Catalina.

The family was presented with the Service Medals of one of the lost crew and a uniform buckle found at the crash site. It was a sad but loving closure for members of the

CEO's perspective

Recent years have seen remarkable change in our community due mainly to the worldwide pandemic, along with the changing expectations of communities and the accountabilities of governments and organisations to those communities.

The Air Force Association (Western Australian Division) Incorporated, (RAAFA) has had to respond to multiple changes that impact on the operation, compliance, and future business needs. Most organisations across the country have had to

undertake a re-examination of how they operate, the appropriateness of their governance structures and how they respond to the increasing legislation and compliance requirements.

I have mentioned previously in this publication the need for us to review our current Rules/ Constitution to ensure that we reflect the requirements of these increasing compliance needs.

We recently had an audit by the Australian Charities Not-For-Profit Commission (ACNC) with a request to explain how we, as an organisation, display through action, our entitlement for Public Benevolent Institution (PBI) status. Our charitable status is dependent on how we purse our benevolent objects in our day-to-day activities. For example, we are required to report how much of our revenue was used to pursue our objects, as stated in our current Rules/Constitution.

The ACNC is currently conducting audits across all charitable organisations, with many now being non-compliant and losing their Public Benevolence Institution and

Charitable Status. This is primarily because organisations are not able to show evidence of their endeavours in the pursuit of their stated objects. RAAFA has fulfilled our requirements with the ACNC, but we need to amend RAAFA's objects within our current Rules/Constitution as recommended by the ACNC to better reflect what we do in relation to our benevolence.

The proposed amendments to the objects reflect the requirements of the ACNC and has been approved by them. Legal advice has also been sought on all the amendments being proposed and has been endorsed as compliant with the Associations Act requirements. These amendments also protect our tax exemptions and Charitable Gift Recipient status.

The additional opportunity to mirror the new membership structures of the National Air Force Association that's being adopted by all States, will provide broader membership options for current and future RAAFA members.

The Royal Commission into Aged Care Quality and Safety has highlighted the need for increased responsibility in relation to governance of age care services. This has been further reinforced with recent revisions of the Age Care Act by setting standards required for individuals to be directors of organisations that provide care.

This in turn has led to the provision of increased powers as recommended by The Royal Commission delegated to the Age Care Quality and Safety Commission that undertake the quality and compliance review of all aged care facilities to ensure compliance with the Age Care Standards.

Imbedded in these standards is a requirement for a high-level of quality governance of the provider's business, with reviews undertaken on every occasion that the commission visits (usually 3 times per year) each of our residential care facilities.

I thank you all for your consideration of the proposed amendments at the Special General Meeting to be held immediately following the AGM on Friday, 28 October at the RAAFA Club, Bull Creek.

Marking Battle for Australia

Every year on the first Wednesday of September, commemorations are held across the country to mark the Battle for Australia.

And this year, RAAFA's AFME invited the younger generation, in the form of students from All Saints College, to give an address to reflect on the bravery of those who served in the defence of the Australian mainland, and in the subsequent land, air and sea battles in the Coral Sea, Papua and New Guinea.

All Saints students David Duff and Genevieve Ho were the two teenagers chosen to give the address to guests and remind those in attendance of the challenges Australia encountered between 1942 and 1945.

Indeed, the thousands of Australians who engaged in actions against Japanese forces during the Battle for Australia were remembered and, in particular, how their efforts contributed substantially to the defeat of Japan.

A special shout out too, to museum volunteers Alan Guy and Frances Honig (aka Fred and Ginger) who took the opportunity to trip the light fantastic to incidental music played by the school band after the ceremony.

"Lorraine has done a huge amount to help make our community the wonderful place it is," says Cheryl Clark, Amity's estate manager.

who explains the group meets for around five hours every week, which includes having lunch together.

"It was Joan who suggested we start making some quilts for these lovely people who have lost so much and, not only did she inspire us, but we were all really happy to help."

To date, over a dozen warm and beautifully handmade quilts have found their way to grateful Ukrainian refugees, with the group continuing to make more to help provide comfort to many more people in need.

"Anyone who knows anything about quilters will guess that we all have lots of spare fabric that we've collected and stashed over the years, so we thought we'd put it all to good use and we're loving pitching in and quilting for a cause," adds Janice.

Bloomin' good sensory experience

Social interaction and meaningful contact are the aims of a new sensory experience focused on enriching the lives of Meadow Springs seniors as part of a new refurbishment of the estate's Wellness Centre.

As part of the project, a landscaper and an arborist were engaged to create a space for residents, families and friends, which is hallmarked by peace and tranquillity.

Wellbeing Officer, Mischa Matthews, said having a newly revamped calm and relaxed space will open up opportunities to run small and intimate activities in the garden, such as relaxation, mindfulness, massage, aromatherapy and morning teas for residents and carers.

"We all want to have meaningful and fulfilled lives but often in our quest to do so, we make ourselves so busy we don't really notice or appreciate moments of fun or relaxation," she says.

"By using light, sound, scents, and colour in and out of our Wellbeing

Centre, we hope to initiate sensations that have both relaxing and activating effects that promote wellbeing, and also provide a space where meaningful interactions can take place.

"Research has shown that touch sensations actually promote concentration and alertness, so the garden should be a very beneficial addition for all of our residents here at Meadow Springs."

In addition, new fencing has been installed to provide residents with an enhanced view of the area.

"Although many people perceive seniors to have an enjoyable and calm life, RAAFA recognise that many seniors are under quite a lot of stress, some live alone, others may have problems with family or illness," Mischa adds.

"So, it's important for seniors to have simple tools in dealing with day-to-day stress, so they can learn how to develop more peace of mind and lessen worry, especially for those residents who are also caregivers."



Dice and drizzle with a difference

Variety is the spice of life, so they say, and culinary variety is certainly something that seniors at McNamara Lodge are experiencing thanks to a new monthly-themed cuisine initiative, which is the brainchild of the home's care and kitchen team.

The 'cooking different cuisines' initiative has been brought about by the fact that seniors are no longer going to different restaurants because of COVID-19 concerns, so the kitchen team have instead rustled up a host of different cuisines to serve to residents in their own home.

To date, a number of Italian, Indian, Asian, Spanish, Chinese, Irish and Mexican meals have been lovingly made by the kitchen staff, with resident favourites including lasagne, ravioli, curries, stir fries and Mexican faiitas.

Viktoria Szasz, Lifestyle Coordinator at McNamara Lodge, explains there are four houses in the lodge Lodge, and every Tuesday residents from one of the homes attends the activity room at lunchtime to sample, sip and savour a new dish, while sitting in the 'restaurant' which has been decorated to reflect the relevant cuisine.

"Residents are also encouraged to dress in the theme of the country whose cuisine we will be sampling, and then we all sit down and enjoy traditional dishes from that nation," she says.

"Essentially this initiative has come about due to the pandemic and the fact that our usual eating out experiences have been curtailed.

"So, we have brought the dining out experience to McNamara Lodge, and not only do the residents thoroughly enjoy it and dress for the occasion, it's also wonderful to see the joy on their faces as they try the different food we've prepared for them."

Trish Jenkins, Food and Beverage Manager, says although making new and very different food can be a challenge, seeing the excitement and joy in the room, along with many happy faces, makes everything worthwhile.

"We pride ourselves on the nourishing and healthy food we prepare at McNamara Lodge, so adding these traditional homecooked meals, which have been lovingly prepared, has been a wonderful addition to our menu," she says.

"We've had residents who originally hail from India loving lasagne and

ravioli, and other residents who spent their childhood in Italy trying Indian curries and it's been heartwarming to see the pleasure on their faces as they've tried different tastes and flavours, sometimes for the first time.

"The staff have also embraced the initiative and we've found it to be a really wonderful way of building our little community here at McNamara Lodge, and also strengthening the relationships our residents have with both other residents and our care

And these sentiments are very much confirmed by residents.

Senior Elda Devenish says she really enjoys the special lunches. "And having music in the background from different cultures, while we are dining, is also really special," she says.

Resident Norma Maguire agrees. "It's a really nice change and we've all been thoroughly enjoying our Tuesday lunches. The therapy team goes to huge lengths to make us feel special by decorating the room and also dressing in national costumes, they always go above and beyond, without fail."

To which, we say to all the team at McNamara Lodge, Bon Appetit!

Bad hair days banished



Tornado whips up nostalgia

If there's one thing that RAF Wing Commander Erica Ferguson and the six-member specialist RAF Joint Aircraft Recovery and Transportation Squadron (JARTS) team unanimously agreed upon during their time in Perth, it was that they received a huge welcome, wonderful hospitality and incredible warmth from RAAFA's community.

"We experienced an amazing welcome and great friendship from the Board, staff and volunteers during our visit, and we very much look forward to visiting again and exploring the stories that the team at the museum are set to share," she says.

WGCDR Ferguson and the JARTS team spent a week in Perth in late June, during which time the gifted Tornado GR4 – the only one of its kind in the world on display outside of the UK – was meticulously pieced back together and put on show at RAAFA's Aviation Heritage Museum.

"I had 63 requests from museums for a Tornado, but when I saw how great the stories already being told out of Bull Creek were, and how amazingly skilled and dedicated the volunteers and staff are at Perth's Aviation Heritage Museum, it was quite an easy choice to make," says WGCDR Ferguson, who began her RAF career as Air Traffic Controller and is now Head of RAF Heritage.

And the rest, as they say, is history, with the disassembled Tornado arriving in Perth by ship in May - the culmination of a three-year project headed by WGCDR Ferguson in conjunction with the specialised JARTS team, which was involved every step of the way.

RAF Warrant Officer Keith Davies was the first person to gain a call from WGCDR Ferguson after she had made the decision to gift the military aircraft – which first flew on 28 June 1992 – to the small museum located in the world's most isolated city.

"I remember speaking to WGCDR Ferguson about the prospect of getting the Tornado 9,000 miles across the world, and my reply was 'nothing is impossible'," says the 43-year-old, who was born and brought up in South Wales and who joined the RAF when he was 16 years old.

"And here we are having assembled the Tornado and, in the process, undertaken daily Q&A sessions with the museum volunteers, from pilots to aviation technicians to Vietnam vets, all of whom have been keen to learn more about the aircraft and its story, and also tell us their own unique experiences."

RAF Chief Technician Chris Mee, known by his colleagues as Sven, was responsible for project managing and planning the Tornado's relocation to Perth.

"It was important to try to reduce the cost of shipping for the museum, so it was our aim to flat pack the aircraft into the most efficient area possible and maximise every inch of space," says the 42-year-old who has served in the RAF for over 23 years, and for whom the trip to Perth was his third visit to Australia.

"Seeing the Tornado in its new home is incredibly rewarding, and also having the opportunity to gain some work / life balance and see the city of Perth and many of its attractions while we've been here has also been amazing."

For 35-year-old senior aircraft technician and JARTS team member Matt Stoffell, the highlight of the week was most definitely meeting the museum volunteers and realising the enthusiasm they have for the Tornado.

"For us we are just doing our job and you can get a little blasé about working on the jet, but after chatting to the volunteers and seeing their interest, you have a renewed appreciation for how cool working with the Tornado really is," says Matt, whose trip to Perth heralded his first visit to Australia.

"It was also interesting to hear the adventures of the volunteers and staff when they were around my age, and of course I have to say that holding a koala was a highlight of the week too, that was most definitely therapy for the soul," he laughs.

For aircraft engineering specialist Andy Morrey, whose career in the Royal Navy spans over 20 years, the opportunity to visit Australia as part of the JARTS team has been a memorable experience.

"Being a member of JARTS is truly unique and it's something I love," says the 42-year-old who hails from Bath in England.

"I'm the token Navy guy in the team and this has really been a dream job for me. I've been fortunate enough to go all over the world with the Navy, but this has been an absolutely brilliant experience and I certainly have some amazing stories to tell my 17-year-old son when I get home."

And for RAF Corporal Michael Broad, known by all his colleagues as Broady, the week-long Tornado project, for which he was deputy team leader, went seamlessly to plan.

"As a team, we've reassembled a few Tornadoes now, so we have the system down well and we were pleased that everything went to time and, luckily, everything slotted into place," he says.

"I think we've all been struck at how friendly and sociable everyone has been, and how happy they've been to chat to us. We are all taking home great memories of our week in Perth, everybody made us feel incredibly looked after."

Significantly, JARTS team member and Sergeant Craig Rogerson has particular history with the museum's Tornado, having undertaken mechanical maintenance on it during six separate tours of duty, while he was based in Cyprus and the aircraft was being used in the Afghanistan conflict.

"I felt quite nostalgic, thinking that assembling the Tornado in Perth is really the last time I get to work on it," says the 37-year-old Englishman who was born in County Durham.

"I always wanted to work on this aircraft, and always wanted to be on a Tornado squadron, so it's actually a strange feeling to see the jet that I've worked on all over the world, and have helped to look after so carefully, now in its last resting place in a museum.

"But the time we've had in Perth has been incredible, and it's been a great opportunity to hear the stories and tales of other service personnel and relate them to my own.

"I gained a real sense that I'll be telling some of my own aviation adventures and RAF experiences to the next generation in what will probably feel like just a few short years' time."

Sergeant Rogerson's comments meld with those of WGCDR Ferguson, who emphasises how the RAF's heritage is essentially an ethos builder – a handrail that helps the armed forces to garner support during dark and testing times.

"Heritage also gives us an unbridled opportunity to engage, interest, inform and entertain the wider population so that they better understand the role and purpose of their military personnel," WGCDR Ferguson adds.

"And in handing over this aircraft, we hand over a heavy responsibility, not just in terms of its curation, but equally the responsibility to share the stories of this specific Tornado GR4, and of the men and women whose lives have been touched by its magnificence over the past 30 years."

Flags flying

Australian National Flag Day is an opportunity for us all to celebrate with pride the anniversary of the Australian National Flag.

And to do just that, RAAFA held a special event at the Aviation Heritage Museum on the day itself – 3 September – with special guests The Honourable Patrick Gorman MP, Assistant Minister to the Prime Minister, and Sam Lim MP, Member for Tangney.

RAAFA was also pleased to

welcome students from All Saints College, as well as 713 Squadron cadets, with Army and Navy representatives.

During the event, Assistant Minister Gorman launched the new and updated national symbols resources and presented All Saints College students with a range of associated booklets and posters.

Assistant Minister Gorman and Mr Lim then completed an inspection of the cadets, while navy and army representatives raised the Australian National Flag, the Australian Aboriginal Flag and the Torres Strait Islander Flag.

All Saints' College Year 6 student, Charlotte Lund, then beautifully performed the national anthem.

The Honourable Patrick Gorman MP also donated three new flags to the Aviation Heritage Museum that were



raised in the ceremony, for which we offer our sincere thanks.

Australian National Flag Day, proclaimed in 1996 as a national day, celebrates the first time the flag was flown on 3 September 1901.

- provides notice of such Special General Meeting pursuant to (b) clause 10.8(c) of the Rules of RAAFA, including the following
 - Date: Friday, 28 October 2022

- Place: RAAFA Club, Bull Creek; and
- calls such Special General Meeting for the purpose of considering (c) and voting on the proposed Special Resolutions set out below regarding the replacement of the current Rules of RAAFA with the proposed revised Rules of RAAFA marked 'Annexure A' in accordance with clause 23.1(a) of the Current Rules.

Proposed Special Resolutions

- The members of the Air Force Association (Western Australian Division) Incorporated (RAAFA) are to consider, and if thought fit, pass, with or without amendment, the following resolutions as Special Resolutions (as required under clause 23.1(a) of the Current Rules and section 30(1) of the Associations Incorporation Act 2015 (WA)(Al Act)):
- Subject to the Commissioner (as defined in the AI Act) (Commissioner) approving, and giving its written consent to RAAFA adopting, the revised Rules of RAAFA annexed to the notice and marked 'Annexure A' (New Rules) as required under section 33(2) of the AI Act, the members of RAAFA hereby:
 - adopt, and replace the current Rules of RAAFA with, the New Rules as the rules of RAAFA;
 - agree that the New Rules bind RAAFA and the members of RAAFA as if:
 - A. they formed an agreement on the part of each member of RAAFA to be bound by and observe all the provisions of the New Rules; and
 - B. such agreement was duly executed by each member of RAAFA and RAAFA itself;
 - agree that the New Rules are compliant with the requirements under the AI Act, the Australian Charities

- and Not-for-Profits Commission Act 2012 (Cth) in respect of the charitable status of RAAFA and the Income Tax Assessment Act 1997 (Cth) in respect of the deductible gift recipient status of RAAFA;
- Subject to the passing of the Special Resolutions set out in (a) above, any member of the Division Council is authorised to and
 - (i) lodge the New Rules and any other documents required with the Commissioner and must do so in accordance with the timing and other requirements under the AI Act;
 - (ii) do any other act or enter into any document to give legal effect to the New Rules; and
- Subject to the passing of the Special Resolutions set out in (a) -(c) (b), and further subject to any directions and conditions from the Commissioner, on and from the date on which the Commissioner approves, and gives its written consent to the adoption of, the New Rules, the New Rules are adopted, fully effective and bind RAAFA and each member of RAAFA and the Current Rules cease to apply and are terminated.

Why the change?

Change raises many questions, like why is the Air Force Association (Western Australian Division) Incorporated, (RAAFA) wanting to update the Rules/Constitution; what does it have to do with me; and what are the consequences if we do nothing?

Firstly, and most importantly, RAAFA wants to assure you there is no need to worry. The changes are to comply with current and future expectations from different regulatory bodies which we have outlined in more detail here.

The lift out lists each change, showing the existing item; proposed amendment and the reason why.

Background and why

Over the last 12 months or more the aged care and retirement living industry has been inundated with regulatory changes and it has been necessary to review our Rules/Constitution to ensure that it continues to meet the expectations of the different regulatory bodies that RAAFA is required to comply with.

These changes arise mainly from:

- The Royal Commission into Aged Care Quality and Safety
- Associations Incorporations Act
- The introduction of a new Aged Care Act
- Australian Charities and Not-for-Profits Commission (ACNC) Audits

The outcome has been an ever-increasing expectation around the governance structures of organisations such as RAAFA, as well as increased compliance requirements.

In addition, the ACNC now carries out regular audits of the Rules/ Constitutions of registered charities (which RAAFA is) to ensure that the Rules/Constitution complies with the organisation's specific charitable status. In March this year we were informed by the ACNC that the current

Objects may not be in keeping with its' status as a Public Benevolent Institution (PBI).

What has changed?

As part of the review, we have updated the Rules/Constitution to ensure that RAAFA remains compliant, by:

- Updating the wording used to match current business standards
- Revising the Membership structure to mirror the National AFA structure
- Modifying some clauses to reflect the recommended Model Rules for Associations in WA
- Updating the Objects of the Association to maintain our charitable

The changes that are proposed have been reviewed by legal specialists in Perth and have been reviewed by the ACNC to ensure that they comply with regulatory requirements and the charitable status of RAAFA.

What happens if nothing changes?

As mentioned above, RAAFA was informed earlier this year that the Objects in the current Rules/Constitution may not be in keeping with its status as a Public Benevolent Institution and as such there is a danger RAAFA could lose its charitable status.

The loss of this status will have implications for the exemptions that RAAFA currently enjoys, such as:

- Payroll tax
- Corporation tax
- Stamp duty
- **GST**
- Local government rates

As well as our Deductible Gift Recipient (DGR) status with the ATO.

What now?

The proposed changes to the Rules/Constitution ensure that:

- RAAFA's Governance remains in line with the expectations of the different regulatory bodies
- RAAFA retains its' Public Benevolent Institution status with the ACNC
- RAAFA's Membership structure matches the AFA National body offering more flexibility for Members
- Keeps RAAFA's cost base down to ensure we continue to provide affordable living solutions for residents

In order for the Special Resolution proposed to pass, 75% of members present and entitled to vote must vote in favour.

"Gracelyn made me go, but we had the best day out together,"


laughs Ron, who says he is keen for more of the RAAFA community to become aware of the free zoo pass.

Serving as a family

Remembrance Day is an important day to reflect for centenarian and RAAFA member Alison Thomson, especially as all of her family served their country during WWII.

And very fortunately for the Edinburgh-born 102-year-old, her entire family survived the war years, including herself, as she too was called up to the Women's Royal Air Force when she was 20 years old, and went on to serve for four and a half years with the WRAF.

"I left school when I was 15 and started work as a shop assistant, but in 1940 I was called up and was sent to do training at the depot at RAF Bridgnorth, before being posted to RAF Lossiemouth in Scotland," says Alison, who still lives independently in her own Mount Pleasant home, despite her great age

"During the war years, I also spent time at Bomber Command stations at Mildenhall and Waddington.

"We were very lucky as a family because all of my brothers and sisters were in the army and Air Force, but we all survived, although I did have a cousin in Canada who was tragically killed in the line of duty."

Alison says that despite the hardships of war, she very much enjoyed her time in the WRAF working as an equipment assistant, and as a result made friends from all over the world.

"When the war ended I joined the Edinburgh telephone exchange as a telephonist and soon after met my husband Robert who was also in the services," says Alison.

"You could say it was a bit of a whirlwind romance as we met at a dance and then we were married two weeks later. He had to go to Persia immediately afterwards and I was supposed to join him, but as he'd signed up as a single person I wasn't allowed to go, so I had to wait for a year until he came back."

Despite their unconventional start to married life, Alison and Robert were married for over 70 years, during which time they had two children and Robert, a welding engineer, started his own oil and gas business in London, before transferring it to Scotland when the North Sea's oil was discovered.

Subsequently, the couple managed a thriving business that saw 200 welders and inspectors working within the company at the height of its success.

In 1983, the pair immigrated to Australia, where they joined their daughter who had migrated to Perth two years before.



"I came out on holiday when I was in my early 60s to visit my daughter and her family and just loved it, I've never looked back and still very much enjoy living in Perth," adds Alison, who is a regular for lunch at RAAFA's AFME in Bull Creek.

"To this day, I enjoy maintaining my RAAFA connections and regularly meet my ex-service friends, quite often at the RAAFA Club.

"I know a lot of people at the estate, and I really enjoy the camaraderie still, the club is a great place to spend time and I love catching up with old friends, and meeting new people."

AFME's Remembrance Day service will be held at 11.00am on Friday, 11 November.

"I always wanted to go to sea," says the born and bred Sydneysider who was the middle of three boys. "Ever since I first began learning to read I chose books about ships and boats, it was all I ever wanted to do."

But following his passion wasn't all smooth sailing, as Stewart was unsuccessful in his application to join the Navy after failing his medical examination due to asthma.

"I was completely downhearted as I'd passed all of the other exams, and at the time my family was keen for me to become an accountant. I didn't know what accountants did, but I definitely knew I didn't want to become one," laughs Stewart, who also spent many years in the Sea Scouts as a young lad.

"So I got a job in the school holidays working for a greengrocer, and one day I knocked on a customer's door and a young man answered who explained that he was a sea cadet who was home on leave.

"I immediately threw in the job with the greengrocer and spent the rest of the school holidays visiting every shipping company I could find. That proved life changing, as soon after I was back at school and got summoned to the headmaster's office who explained he had just received a call from a man at a shipping company to ask if I wanted to start work the following week.

"The rest, as they say is history, but needless to say I became a seafarer and eventually a Master Mariner." Stewart spent the next 12 years sailing the world's oceans – 10 of which were needed to become a fully qualified Master Mariner.

"I had many adventures over that time but two stand out in particular," he says

"One was when we were caught in a typhoon; I can vividly remember standing on the bridge of the ship and watching as the bow was buried deep in the water and the only thing I could see was the mast, and then feeling the vessel rear up and shake itself off like a dog. It's times like that when a ship really comes to life and almost becomes a living creature.

"Another memorable experience was when the crew I was with were desperately trying to find the entrance to the Panama Canal in very heavy rain. I was asleep at the time, but suddenly woke up and felt there was something wrong. I went up to the bridge and realised the crew were lost and unsure in which direction to sail. Because I had sailed there before I could remember the landscape a little, and fortuitously there just happened to be a flash of lightning which enabled me to see the headland in the distance. We changed direction from the rocks ahead and I was able to direct the crew safely to land.

"I think if you've been at sea long enough, you develop a sixth sense which is why I'd bizarrely woken up and felt something wasn't right. We were very lucky that day."

It was while he was overseas that Stewart met his wife, Maris, who was working in a London hospital as a radiographer, having trained in her hometown of Perth.

"We met in the Down Under Club which was full of homeless Australians in London," Stewart laughs. "We both caught different ships home and arrived back in Perth on 12 December 1960, and we married a few days later on 17 December."

After having three children, during which time Stewart worked as a Port Inspector, he decided that there was no way he could go back to sea with a wife and young children, so he applied for a job as an Air Traffic Controller, a role that took him and his family to Melbourne and Launceston, and then back to Perth over his 28-year career.

But despite his many years of working in aviation, his passion for

the ocean has never left him. And so, even today, Stewart drives to the South of Perth Yacht Club each week, where he's joined by his skipper of 25 years and a 'young' crew - the youngest of whom is aged 65 - to go sailing.

"I'm the oldest but I still sail for enjoyment and just love being on the water; anyone who has spent time on it will tell you it's both frightening and beautiful," he says.

"When you stand on a ship watching 25-metre waves, you realise how insignificant you are. Being on the ocean is undoubtedly the most enlightening thing and it's a passion I've never lost.

"I feel very fortunate that, even though I'm nearing 90, it's an experience I'm still able to continue to enjoy every week of my life."



Flying high in a new role

The new manager at RAAFA's Aviation Heritage Museum admits he's excited to head up what he describes as one of Perth's best kept secrets.

48-year-old New Zealander, Trent Norris, remembers going to the museum when he first moved to Western Australia many years ago with his Perth-born wife, but admits he hadn't been back until he visited for his job interview.

"I previously worked for the WA Museum as its commercial operations manager across Perth, Fremantle and our regional museums in Kalgoorlie, Albany and Geraldton," says Trent, who was born and raised in a small dairy and farming community about 50km south of Auckland.

"During the 13 years I worked in that role, I was also seconded for a period as the Perth Museum Manager.

"And then when I saw the Aviation Museum job advertised, I jumped at the opportunity.

"When I came here for the interview and had a look around I was blown away. The museum has a phenomenal collection and the volunteers here are a wealth of knowledge, it really is a fantastic place to visit and I'd urge anyone who hasn't been here for a while to pay us a visit and see for yourself."

Trent admits to always having had an interest in aviation, notching up around 40 hours of flying when he was working towards his pilot licence as a young man, before the funds unfortunately ran out.

"I've always loved aviation and, although I don't have an Air Force background, flying is something I'd love to pick up again one day, perhaps when the kids have left school," says the father of two - a 16-year-old son and 14-year-old daughter.

"I'm still on a steep learning curve, but the whole team here is exceptionally helpful, incredibly friendly and the volunteers have just the most remarkable stories, which at times are astonishing to hear.

"Our recently acquired Tornado is the most amazing aircraft. It makes a fantastic addition to our museum and is yet another reason why anyone reading this who hasn't visited us for a while should drop in, perhaps with their grandchildren in tow, and have a look for themselves."

Located at RAAFA's Air Force Memorial Estate in Bull Creek, the Aviation Heritage Museum is open every day of the week from 10.00am to 4.00pm (except Good Friday, Christmas Day, Boxing Day and New Year's Day).

Remembering on Remembrance Day

More than 100 years on from the end of WWI, residents and staff at AFME's Alice Ross-King Care Centre will remember members of the armed forces who served and died in the line of duty, ahead of Remembrance Day on Friday, 11 November. Now aged 103, born and bred West Australian, Tom Newby, will attend a commemorative ceremony at the centre, as one of the declining number of Australians who served in the WWII conflict.

Aged just 21, Tom chose to enlist into the Army in August 1941, when

Australia came under increasing threat by the Japanese.

It meant packing his bags and undergoing training, where, serendipitously, he joined the 4th battalion in New South Wales, after a mortar bomb accident killed 14 young men who needed to be replaced immediately.

Tom subsequently spent time training at Rottnest Island, where he helped to build the island's wartime tunnel system and other underground shelters. This was followed by further training at Moora where he was involved with the coast guards. A little later, he received jungle training near Townsville and was then sent to New Guinea for 29 months, only leaving in March 1946, many months after the war had ended.

Tom, who was born and lived much of his life at Broomehill in the Great Southern, went on to marry his future wife Betty, and the couple had three daughters Mary, Joan and Anne. "Dad didn't talk about the war years for a long time, but in the last decade or so he has opened up a lot more, and he's got very much more involved in things like the ANZAC march in the city," explains youngest daughter Anne.

"I know two of dad's best friends from the battalion were killed in the first week in New Guinea by a grenade, and that very much affected him.

"Remembrance Day as well as ANZAC day is an important and emotional day for dad. It's great to see the team at Alice Ross-King Care Centre taking the time to commemorate the exceptional contribution of all Australian servicemen and women for their bravery and selflessness."




